1. All golf cards and season tickets are for a period valid to 31 March 2023. The price will be calculated pro rata monthly from the date of purchase, unless stated in a special promotional offer.
 2. The number of Season Tickets sold in any one year WILL be limited and are available on first come first served basis – please check with the pro shop for further details.
 3. All golf cards and season tickets are strictly non-transferable, and should they be used incorrectly will be revoked immediately without refund. The South Buckinghamshire Golf Course may also pursue lost income resulting from fraudulent actions.
 4. Payment can be made by debit OR credit card, or a cheque (made payable to Farnham Park Sports Fields).
 5. Part payment or payment by direct debit or standing order is not presently available.
 6. Season Ticket payment is available by invoice; however, VAT will be added to the price shown in this document.
 7. Payment for a golf card, season ticket and any top ups on the flexi card scheme MUST be paid in full at time of purchase. No refund will be given once payment has been received.
 8. Occasionally The South Buckinghamshire may run special promotional offers where the prices are amended; these will be as stated on promotional material.
 9. The age of the applicant at time of application will apply.
 10. The season ticket entitles the holder to pre-paid golf as follows:
 - a. **7 Day** - Monday to Sunday, anytime including Bank Holidays
 - b. **5 Day** - Monday to Friday, anytime, including Bank Holidays.
 11. A golf card allows the bearer to receive a discounted rate for his or her green fee. Please see price list for actual discount
 12. Flexi card allows points to be used to pay for green fees and buggy hire Monday to Sunday, and Bank Holidays. Flexi points can also be used to pay for playing partners.
 13. Application forms MUST be fully completed and returned with payment, to the pro shop.
 14. The South Buckinghamshire reserves the right to refuse the provision of a season ticket to any person, without assigning a reason and will return the application fee to the applicant should this right be invoked.
 15. Season tickets and Flexi card can only be used at The South Buckinghamshire golf course.
 16. Annual season tickets and Flexi cards are only valid for the green fee element for any form of 18, 27 or 36-hole society booking.
 17. Annual season tickets are NOT valid for any Charity golf day organised by The South Buckinghamshire Golf Course.
 18. Annual season tickets and Flexi cards are not valid against any multi ball booking promotional offer.
 19. All golf card holders may book up to 14 days in advance, by phone, or online.
 20. All golf card and season ticket holders can book for up to 3 guests playing with him or her, and is responsible for ensuring payment is received for all bookings.
 21. The golf card holder who makes a booking MUST play at the time booked
 22. Bookings for tee times must be cancelled in accordance with The South Buckinghamshire cancellation policy, in the event that a golf card or season ticket holder is unable to fulfil the booking. Failure to do so may result in The South Buckinghamshire charging the full member fee for all booked and unused tee times.
 23. No refund will be given to a season ticket holder should they be unable to play for any reason, unless supported by a letter from their GP stating the medical reasons why and for how long (minimum one month). On receipt the General Manager will decide whether any partial refund or credit can be granted.

24. The South Buckinghamshire reserves the right to close the course due to weather or maintenance, or restrict tee times for a competition; society or corporate booking and no refunds, credits or extensions will be granted.
25. All golf card, flexi card and season ticket holders must attend the pro shop prior to commencement of their round, so as to confirm attendance and gain a green fee receipt. The receipt **MUST** be carried at all times whilst on the course and produced on demand. Failure to produce a valid receipt may result in the player being asked to pay a green fee or asked to leave the course.
26. The golf card, flexi card or season ticket holder must comply with all rules and policies in place at The South Buckinghamshire, including but not limited to, the cancellation policy, dress code and golfing etiquette, both on and off the course.
27. It is the responsibility of the person, club, society or organisation who has booked the tee time to ensure that all players are well behaved on and off the golf course and follow golf course etiquette, this includes SLOW PLAY and inappropriate and/or offensive language.
28. All golf card, flexi card and season ticket holders and guests, when playing, must adhere to any course signage or notifications given by golf course staff.
29. No refund will be given should the clubhouse or any part of the clubhouse be unavailable due to repair, alteration, maintenance, cleaning, for a period of up to 28 days in any one 12 month period from 1 April, after which time compensation or extension may be considered.
30. No refund will be given should the course be closed as a result of weather conditions.
31. Lockers are provided within the clubhouse, and can be used on a day to day basis; however, items of clothing or equipment must NOT be stored overnight.
32. A renewal notice will be displayed in the golf shop a minimum of 14 days prior to the expiry date of 31 March 2023. It is the responsibility of the golf card and season ticket holder to ensure they renew prior to expiry date, to ensure they have a valid golf card or season ticket.
33. The course and clubhouse will be **CLOSED** on Christmas Day, Boxing Day and New Year's Day.
34. It is the responsibility of the golf card, flexi card or season ticket holder to arrange for appropriate insurance to cover loss or theft of equipment, or damage to other persons, whilst on the course.
35. The South Buckinghamshire reserves the right to alter these terms and conditions as deemed necessary and any changes will be communicated via the noticeboards within the clubhouse and the website.
36. The South Buckinghamshire reserves the right to revoke a golf card, flexi card or season ticket should the holder fail to adhere to these terms and conditions, or if their conduct becomes unacceptable. No refund will be given.
37. All information held relating to this application form will comply with the General Data Protection Regulations 2018.
